AVAILABLE LENGTHS OF PANELS

Standard lengths of panels are from 2,0 m to 14,5 m.

PERMISSIBLE DEVIATIONS FROM DIMENSIONS

According to EN 14509:

Panels with length of ≤ 3 m ± 5 mm

Panels with length of > 3 m ± 10 mm

For the covering width of the sandwich panel, ± 2 mm

At the panel thickness:

For $D \leq 100$ mm ± 2 mm

For $D > 100$ mm ± 2 %

Rectangularity of cut at the length $\leq 0,6$ % of the panel width

Panel:

2 mm per each meter of length, but not more than 20 mm

8,5 mm per each meter of width, but not more than 10 mm
